

Nimi – Terms of Service

1. About Nimi

Nimi (“Nimi”, “we”, “us”, or “our”) is operated by **Meyer Way Capital Limited**, a company incorporated in England and Wales. Registered office: 85 Tottenham Court Road, Camden, London, England

Nimi provides a digital platform that enables users to discover events, purchase tickets, manage memberships, and place food and beverage orders through third-party event organizers, venues, clubs, and partners (“Partners”). Nimi acts solely as a technology intermediary and does not own, manage, or operate events, venues, hospitality services, or payment systems unless expressly stated otherwise.

2. Eligibility

You must be at least eighteen (18) years old, or the legal age required for the relevant activity in your jurisdiction, to use the Services. By accessing or using the Services, you represent and warrant that you meet these requirements and have the legal capacity to enter into a binding agreement.

3. Acceptance of These Terms

By accessing or using the Services, you agree to be legally bound by these Terms. We may modify these Terms from time to time. Material changes will be reflected by updating the “Last updated” date. Your continued use of the Services after changes take effect constitutes acceptance of the revised Terms.

4. Description of the Services

The Services provide a digital platform enabling users to interact with events, memberships, and hospitality offerings offered by third parties. Nimi does not guarantee the accuracy, availability, or quality of events, products, or services provided by Partners. Any contractual relationship formed through the Services is solely between the user and the relevant Partner.

5. Accounts and Security

Certain features of the Services require account registration. You agree to provide accurate and complete information and to keep your login credentials secure. You are responsible for all activity conducted through your account. Nimi is not liable for losses arising from unauthorized access where you have failed to safeguard your credentials.

6. Payments and Billing

Payments are processed by third-party payment providers. Nimi does not store full payment card details. Depending on the transaction, payments may include platform fees payable to Nimi and amounts payable to Partners or Event Organizers. All prices displayed are inclusive of applicable taxes unless stated otherwise.

7. Events and Ticketing

Tickets available through the Services are sold by Event Organizers. Nimi is not responsible for the organization, execution, cancellation, or modification of events. Refunds and cancellations are governed by the Event Organizer’s policies and applicable consumer protection laws.

8. Food and Beverage Orders

Food and beverage orders are contracts directly between users and Partners. Nimi acts solely as an intermediary. Partners are responsible for compliance with food safety, licensing, and age-verification laws. Nimi bears no responsibility

for the preparation, quality, or delivery of items.

9. Data Protection and GDPR

Nimi processes personal data in accordance with UK GDPR and EU GDPR where applicable. Nimi acts as a Data Controller for platform operations and as a Data Processor when processing personal data on behalf of Partners. Users have rights to access, rectify, erase, restrict, and object to processing of their personal data. International data transfers are safeguarded using approved legal mechanisms.

10. Cookies and Tracking

The Services use cookies and similar technologies to ensure functionality, analyze usage, and improve user experience. Where required by law, consent will be obtained for non-essential cookies.

11. Intellectual Property

All intellectual property rights in the Services and related materials belong to Nimi or its licensors. You may not copy, distribute, modify, or exploit any part of the Services without prior written consent.

12. Acceptable Use

You agree not to misuse the Services, engage in unlawful activity, interfere with platform security, or infringe third-party rights. Violation of these rules may result in immediate suspension or termination of access.

13. Suspension and Termination
